The Name of Work, Estimated Cost and Dates of Opening, Name of the contractor with address etc. shall be clearly indicated on all the three envelops properly by the contractors. During opening, if EARNEST MONEY is not found in the proper and prescribe form the tender shall be summarily rejected.
- (5) Duly filled and signed tenders will be received upto 3:00 p.m on 11-01-2010 in the Office of The Controller of Administration, NEIST, Jorhat and will be opened on the same day at 3:30 pm in the presence of the intending contractors or their authorized representatives. The earnest money as mentioned above as demond draft/ Banker's Cheque/ Pay Order/ Deposit at call receipt, issued by any recognized Bank only, in favour of DIRECTOR, North-East Institute of Science & Technology, Jorhat only.
